



Personalized medicine S3P4PM - 5 KEY PRIORITIES

- 1. To find new potential diagnostic and prognostic biomarkers.
- 2. To identify and investigate novel potential targets for treatment.
- 3. To find and validate pharmacogenomic markers of treatment response that will support personalized medicine.
- 4. To implement preemptive pharmacogenomics testing into clinical practice.
- 5. To finish the development of <u>CD34 cell therapy product</u> for <u>hematologic/oncologic indications</u> and a clinical study thereafter. This kind of therapy is a clinical need for many patients who do not have a fully matched donor.

coalition partners – quadruple helix (Govt, Industry, R&A, Civil Society)

participation in horizontal activities of EIP AHA: Blueprint, I2M, MAFEIP

6 criteria: Criterion 1. Political, Organisational, Technological and Financial Readiness Criterion 2. Sharing learning, knowledge and resources for innovation **Criterion 3. Strategic readiness: The following strategies have been adopted

Strategy of Long-living Society, Nutrition and Physical Activity, dementia, cancer treatment, quality and safety in HC, physical activity for elderly by social care centres and NGOs), day care centres for elderly, 24 life service for the elderly supports independent living.

Empowered patient **mass** responsible, proactive patient




